This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and The HHI Kolkata as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, notfor-profit, industry led and industry managed organisation playing a proactive role in India's development

Yi was formed in the year 2002 with an objective of creating a platform for Young Indians to realize the dream of a developed nation.
